**Minutes of the Spot Visit & Inspection held on 30.09.2019**

Minutes of the spot visit on 30.09.2019 & inspection of demolished houses of BC community at Survey No. 32, Pragathi Nagar, Serlingampally Mandal, Gachibowli, Rangareddy District, Hyderabad. On spot meeting with representative/victims/ effected family members along with District Collector, Commissioner of Police/ SSP, Hyderabad, District BC Welfare Officer & other concerned officer of the district.

**Brief of the Case:-**

In this connection, the representatives stated that they are landless poor and downtrodden persons living by working as daily labours, doing petty business etc. They further informed that company IIC (Indotronix International Corporation Service India Pvt. Ltd), RTC Cross roads, Hyderabad along with large number of antisocial elements with the help of police department have illegally tress passed into their houses and forced to vacate the premises. They also submitted that police authorities threatened to arrest them by foisting false cases if they interfere in their work. Their household articles were thrown out on roads and threaten not to enter into this land. They were forced to sign on blank paper and written paper saying "you have received certain amounts to vacant the land".

They further alleged that local police are providing full co-operation to the company persons and are demolishing their houses. The company persons hand in glove with local police are trying to take possession of the Pragathi Society locality.

After discussion with the affected victims, their family members and representatives in detail, Commission raised the following questions to be replied/ submitted by the concerned district officials within 07 days positively:-

**Questionnaire concerned with District Collector, Rangareddy District, Hyderabad:-**

1. How many acres of land are there in Survey No. 32 of Pragathi Nagar, Serlingampally Mandal, Gachibowli, Rangareddy District?
2. How much is government lands are there in Survey No. 32?
3. How much is private lands are there in Survey No. 32?
4. Have the district officials have done the survey before demarcation of Survey No.32?
5. Does the district officials have any information that 165 families living in the govt. land of Survey No. 32 are residing since 08 years under Pragathi Nagar colony?
6. Had the district authorities allotted government land to anyone where there is private land?
7. District officials have any knowledge about the residents who are residing in the govt. land since long having Aadhar card, voter ID card, Power / Electric connection, water connection, house tax etc. in their name?
8. Do you have letter copy of G.O. 58,59 regarding government endorsing the survey no. 32 govt. lands in the year 2019 July, June, April?
9. Whether district official received any representation in past for regularizing of houses under G.O. NO. 58, 59 to MRO/ RDO & Collector? Provide details.
10. Is there any correspondence among the MRO/ RDO/DC regarding regularization of houses in Survey No. 32?
11. Is there any temple/ church/ mosque/ Ambedkar status in the survey no. 32?
12. Do you have any information that on 30.7.2019 police arrested residents of Pragathi Nagar and destroyed houses by private persons?

13. When government has declared the land in question is a private land?
14. How private persons/ company take possession of survey no. 32, a disputed land before demarcation? Explain
15. What action taken by the district authorities to control the dispute in the matter?

**Questionnaire concerned with Greater Hyderabad Municipal Corporation (GHMC):-**

1. Whether GHMC has taken any action in the matter of Survey No. 32?
2. Whether GHMC has taken any action on recent unauthorized construction?
3. Whether GHMC given any permission for construction of houses in Survey No. 32? Provide details.
4. Whether GHMC destroyed the houses of the survey No. 32?
5. How some houses were demolished ignoring the directions of Hon'ble Court?

**Questionnaire concerned with Commissioner of Police, Cyberabad:-**

1. Court given a direction to inquire and submit a report on disputed land case of survey no. 32, Pragathi Nagar.
2. How some houses were demolished ignoring the directions of Hon'ble Court?
3. Why police supported and allowed private persons to enter and demolish the houses? Is it in the knowledge of the police authorities?
4. Any representation from the residents of the said land received by the police authorities?
5. Whether any case registered on the wrongdoers/ criminal in the matter? Provide a copy of FIR and pending under trail cases?
6. On what grounds many complaints booked under IPC 447, 427, 468, 471, 474, 506 R/w 34 on residents of Pragathi Nagar?
7. Police have to take action against after executive petition (I.P) by court but in this case how police and review department supported private people? Explanation
8. A statue of Ambedkar is there on the land (survey no.32)? Yes or No.
9. Any investigation on the matter of Removal of Ambedkar status from the land?

A reply of the above questionnaire may be submitted to the Commission within 15 days positively for examination further. Next date of hearing fixed is **03-December, 2019** at **2 P.M.** for your appearance in person at NCBC headquarters, Trikoot -1, Bhikaji Cama Place, New Delhi.
