Sir

The National Commission for Backward Classes therein after called the Commission) has been constituted under new article 338B of the constitution of India. As amended by the Constitution (One hundred & Second Amendments) Act 2018, the commission shall have the power to regulate its own procedure. It shall be the duty of the commission to investigate and monitor all matters relating to the safeguards provided for the socially and educationally backward classes under this constitution or under any other law for the time being in force or under any order of the government and to evaluate the working of such safeguards.

2. On the reference cited above, Commission observed that the statement in the report submitted by the DCP, Pimpri represent that DCP who came on behalf of CP & DGP was not well conversant with the facts of the case. Hence, it is further instructed that presence of DGP/IG level officer from the office of Director

The petitioner will also be advised to be present in the hearing.
- Please take notice that in case you fail to attend the hearing; the Commission is at liberty to exercise the powers of Civil Court under clause (8) of article 338 B of the Constitution of India for enforcing attendance before the Commission.
