
Subject: Representation received from Mr Tekchand S/O Late Shri Khajan Singh dated 22/04/2020 regarding providing acquisition of the allotted land.

The National Commission for Backward Classes (herein after called the commission) has been constituted under new article 338B of the constitution of India. It shall be the duty of the commission to investigate and monitor all matters relating to the safeguards provided for the socially and educationally backward classes under this constitution or under any other law for the time being in force or under any order of the government and to evaluate the working of such safeguards.

Stamp paper (Rs.10/-) may be brought with you to furnish reply on affidavit to the commission as per the requirement. The petitioner is advised to be present in the hearing.

4. Please take notice that in case you fail to attend the hearing, the Commission is its liberty to exercise the powers of Civil Court under clause (8) of article 338 B of the Constitution of India for enforcing your attendance before the Commission.
