Accordingly, you are requested to appear in person for hearing before the Hon'ble Vice Chairman on the above scheduled date and time along with the full facts and all relevant original records/documents pertaining to the case. Stamp paper (Rs.10/-) may be brought with you to furnish reply on affidavit to the commission as per the requirement. The petitioner is advised to be present in the hearing.

4. Please take notice that in case you fail to attend the hearing, the Commission is at liberty to exercise the powers of Civil Court under clause (8) of article 338 B of the Constitution of India for enforcing your attendance before the Commission.
