The National Commission for Backward Classes (herein after called the Commission) has been constituted under article 338 B of the Constitution of India. Personal Appearance is mandatory.

4. Please take notice that in case you fail to attend the hearing, the Commission is at liberty to exercise the powers of Civil Court under clause (8) of article 338 B of the Constitution of India for enforcing your attendance before the Commission.
