On the basis of the Public Hearings held by the Commission as well as detailed reasons & justification regarding why the said caste/community should be included in the Central List of OBCs, the Commission shall tender its advice to the Central Government as it deems appropriate. Advice of the Commission shall be duly signed and authenticated by Chairperson, Vice Chairperson and all Members of the Commission.

Members of the commission will expedite hearings to dispose of the pending references expeditiously.
