OFFICE MEMORANDUM

Subject: Reservation for SCs, STs and OBCs in autonomous bodies/ institutions etc.

The undersigned is directed to say that instructions were issued vide Ministry of Home Affairs' O.M. No. 39/40/74-SCT (I) dated 30.9.1974 that the autonomous bodies/ institutions, which receive grant-in-aid from the Government of India, would make suitable provision in the relevant Statutes or in the Articles of Association of the respective bodies to provide reservation for Scheduled Castes (SCs) and Scheduled Tribes (STs) in services under their control. After introduction of reservation for Other Backward Classes (OBCs) on 8.9.1993, the autonomous bodies etc. were expected to make provision in this regard also. It has been brought to the notice of this Department that some of the autonomous bodies/ institutions have not made suitable provision about reservation in their Statutes/ Articles of Association.

2. All the Ministries/ Departments etc. are requested to ensure that suitable provisions of reservation for SCs, STs and OBCs are made in the Statutes/ Articles of Association of all the autonomous bodies/ institutions under them and such provisions are implemented scrupulously.
