It is found that information under the entry 'Service' in Report-II (Copy enclosed) regarding representation of SCs, STs, and OBCs in different grades of various Groups 'A' Services is not provided by most of the Ministries/Departments.

2. It is requested that the entry regarding service of the Employees i.e. Indian Administrative Service (IAS), Indian Telecommunication Service (ITS), Central Secretariat Service (CSS), Indian audit and Accounts Service (IA&AS), Indian Postal Service (IPS), Indian Revenue Service (IRS), etc. be properly be made in Report-II. An illustrative list of such services is enclosed. At the same time it is to be ensured that the reports duly filled with correct information may only be furnished to Department.

3. It is further requested that duly filled Report-II about grade wise representation of SCs, STs and OBCs in various Group 'A' services under the Central Government as on 1.1.2009, 1.1.2010 and 1.1.2011 may be furnished to this Department at the earliest.
