



I am directed to seek the detailed answers of the questions listed here below for your kind information and to request you to furnish a detailed action taken report on the asked questions to this commission **within 03 days** from the date of receipt of this letter for further examination. The questions listed here as follows:

- a) Kindly provide the certified copies (self-attested) of the roster of Teaching and Non-Teaching till date.
- b) Details of Sanctioned Teaching Staff Strength (Category wise) and Details of filled-up positions (Category wise).
- c) Details of the backlog posts of Assistant Professors, Associate Professors and Professors till date.
- d) Details of the no. of subject wise seats vacant till date and details of ad-hoc/guest faculties working in the University.
- e) Detailed information about vacant posts keeping in mind the reserved category of each subject.
- f) How many times roster has been recast in the University? Provide the certified copy (self-attested) of all Rosters.
- g) Provide the certified copies of the Rosters of Guest and Ad-hoc Teaching Staff.
- h) Is it true that the Hon'ble Supreme Court has not only upheld the validity of FR 56 J but has also decided that no show cause notice (not less than 03 months) is required to issue to a public servant before pre-mature retirement under the said provision?
- i) Is it true that the University has received a letter under Rule 48 of the Basic Rules FR 56 (J) and CCS (Pension) Rules 1972 for review from time to time, which strengthens the administration, if so, what action has been taken against incompetent officers so far?
- j) Have the Vice Chancellor or Registrar of the University aware that Central Educational Institutions (Reservation in Admission) Amendment Act, 2012 and Central Educational Institutions (Reservations in Teachers' Cadre Act, 2019 applies to Central University of Haryana.
