1. The National Commission for Backward Classes (herein after called the commission) has been constituted under new article 338B of the constitution of India. It shall be the duty of the commission to investigate and monitor all matters relating to the safeguards provided for the socially and educationally backward classes under this constitution or under any other law for the time being in force or under any order of the government and to evaluate the working of such safeguards.



2. **Dr. Bhagwan Lal Sahni**, Hon'ble Chairman, National Commission for Backward Classes, have fixed a hearing on **21.12.2021** at **2:30 PM** in Chamber of Hon'ble Chairman, First Floor, Trikoot-I, Bhikaji Cama Place, New Delhi-110066 for Investigation /Inquiry/action to be taken in the matter
3. Accordingly, you are requested to **appear in person for hearing** before the Hon'ble Chairman, NCBC on the above scheduled date and time along with full facts and all relevant original records/ documents pertaining to the case. Stamp Paper (Rs.10/-) may be bought with you to furnish reply on affidavit to the Commission as per the requirement. The petitioner is also advised to be present in hearing.
4. Please take notice that in case you fail to attend the hearing, the Commission is its liberty to exercise the powers of Civil Court under clause (8) of article 338 B of the Constitution of India for enforcing your attendance before the Commission.

The Vice Chancellor and Registrar of University of Delhi are required to present the following details at the abovementioned Hearing on 21st December:

- A. Complete details on all those who are eligible to be promoted in different categories of Assistant, Associate and Professorship, and those granted promotions and those who are still waiting and their categories as SC/ST/OBC.
 - B. Full details on Students Undergraduate Admissions in different Colleges. Total seats available and seats on which admissions have been done and their categories as SC/ST/OBC. Seats Vacant and their Categories.
 - C. Full details on all NFS done in matters of appointment of Assistant Professors in last 6 months, including in Daulat Ram College, Swami Shraddhanand College and other Colleges of University of Delhi.
 - D. Full details of Teachers appointed on Guest Basis in Colleges of University of Delhi, NCWEB and School of Open Learning and their categories as SC/ST/OBC.
 - E. Present status of Reservations in seat allotment to students in all Post Graduate Hostels of University of Delhi, and Undergraduate Hostels of University of Delhi. University should also certify whether funds were allotted to these Hostels as granted by UGC and Government of India under OBC expansion scheme previously and the use of this fund, if granted.
5. This issue with the approval of Competent Authority, NCBC.
